**NOTICE TO CONTRACTORS**

INVITING SEALED PROPOSALS

1. NOTICE IS HEREBY GIVEN that sealed Proposals will be received by the **Board of Supervisors, County of Marin, Administration Building, 3501 Civic Center Drive, Room 329, San Rafael, California 94903**, until **2:00 p.m. on Tuesday, April 17, 2007** for: **MARIN COUNTY GARAGE MECHANICAL IMPROVEMENTS, Project No. CAP-92533-01**, for which a "C-20" license will be required.

**Project Description: Replace three existing indoor furnaces with three new packaged units placed on the exterior of the building.**

**A prebid conference will be held at 2:00 p.m. on Wednesday, March 21, 2007, at the County Garage, #6 Peter Behr Drive, San Rafael.**

2. The Engineer's estimated cost for the accomplishment of this work is **\$170,000**.
3. The work shall be performed in accordance with official Drawings, Specifications, and other Contract Documents prepared in reference thereto which may be examined at the Department of Public Works, 3501 Civic Center Dr., Room 404, Marin County Civic Center Administration Building, San Rafael, California, and selected Bay Area builders exchanges and trade publications.
4. Copies of the Project Drawings, Specifications and other Bid Documents may be acquired by prospective Bidders at The Marin County Department of Public Works upon payment of \$50.00 per set (cash, or check made payable to the County of Marin) to cover the cost of printing and processing, which payment is NON-REFUNDABLE, and the documents need not be returned. There will be a \$10.00 service fee for returned checks. Mailed requests should be addressed to the Marin County Department of Public Works, County of Marin, Attention: Capital Projects Division, P.O. Box 4186, Civic Center Branch, San Rafael, California 94913-4186.
5. For detailed information regarding the scope of the Project, Bidders may contact the Capital Projects Division of the Marin County Department of Public Works; telephone number 415/499-7877.
6. All Bids must be submitted on the Proposal Form bound in the Project Manual, or a copy thereof, and must be accompanied with a Proposal Guaranty of at least 10% of the amount of the Base bid.

7. Sealed Proposals will be received until the time and in the place stated above, and shortly thereafter will be **publicly opened and read aloud in Room 404**, Administration Building, Marin County Civic Center.
8. The award of the Contract, if it be awarded, will be to the lowest responsible Bidder whose Proposal complies with the prescribed requirements, and will be made within thirty (30) calendar days after the bid opening. The Board of Supervisors reserves the right to reject any or all bids and to waive any irregularity in any bid received.
9. Pursuant to Section 1773 of the Labor Code, the general prevailing wage rates for Marin County where the work is to be done have been determined by the Director of the California Department of Industrial Relations. These wages are set forth in the General Prevailing Wage Rates for this project, available at the Department of Public Works, and are also available at the State of California Division of Labor Statistics and research web site at <http://www.dir.ca.gov/DLSR/PWD/index.htm>.
10. The County of Marin, and its Contractors and/or Subcontractors will not discriminate against any individual based on race, color, religion, nationality, sex, age or disabled condition.
