WHEREAS, through his vision, leadership, abilities and team-oriented philosophy a number of services have dramatically improved, including Emergency Medical Services, Hazardous Materials Response, Marin County Urban Search & Rescue Team (USAR), Dive Team Operations, Community Emergency Response Training (CERT), Teen CERT, Wellness/Fitness program for Firefighters, and a number of consolidations among districts have been accomplished: Tamalpais with Mill Valley, Tamalpais with Alto, and Southern Marin Fire with Sausalito; and

WHEREAS, Chief Stone's leadership, with the goal of giving the best possible service to the community with which he is involved, has benefited both his employees, the District which he serves and the County as a whole; and

WHEREAS, in addition to these many accomplishments, Chief Stone's relationship with the people with whom he has worked has been exceptional. He has provided vision in operations and administration, and has set a high standard for his employees, allowing them to work independently and with self-motivation; and

WHEREAS, Chief Stone's kindness and generosity in giving of his time, resources and care are very noteworthy for one in his position, creating a strong family feeling and making him much beloved by those who serve with him; and

WHEREAS, most importantly, Chief Stone has a loving family - his wife, Carol, his daughters, Lindsey and Stacey, and his son, Brett, who has just joined the Fire District as a Reserve Firefighter; and

WHEREAS, the Marin County Board of Supervisors wishes to express its gratitude for the many contributions that Chief Robert L. "Mike" Stone has made to both his Fire District and to the County of Marin as a whole.
