**WHEREAS**, it is necessary that the sum of up to and not to exceed \$800,000.00 be transferred from funds in the custody of the Treasurer of the County of Marin to Marinwood Community Service District, for meeting the obligations incurred for maintenance purposes by said entity for the 2008-2009 fiscal year.

**NOW, THEREFORE, BE IT RESOLVED, ORDERED AND DECLARED** that the Treasurer of The County of Marin be and is hereby authorized and directed to transfer from the funds in his custody to Marinwood Community Service District, the sum of up to and not to exceed \$800,000.00, said sum to be used for meeting the obligations incurred for maintenance purposes. Said sum does not exceed eighty five percent (85%) of the anticipated revenues accruing to said entity and shall be replaced from the revenues accruing to said entity before any other obligations are met from said revenues.

## RESOLUTION OF THE BOARD OF DIRECTORS OF MARINWOOD COMMUNITY SERVICES DISTRICT REGUESTING TEMPORARY TRANSFER OF FUNDS FROM MARIN COUNTY TREASURER

WHEREAS, the Board of Directors of Marinwood Community Services District ("District") finds that the funds it has on deposit with Treasurer of the County of Marin and in commercial bank deposits will be insufficient to meet the operational and maintenance requirements of the District prior to the first distribution of property tax revenues for the Fiscal Year 2008-2009 in December 2008;

NOW, THEREFORE, BE IT RESOLVED, in accordance with Article XVI, Section 6 of the Constitution of the State of California, that Marinwood Community Services District requests the sum of \$800,000 be transferred from funds in the custody of the Treasurer of the County of Marin to Marinwood Community Services District for meeting the obligations incurred for maintenance purposes for the Fiscal Year 2008-2009, (July 1 through the last Monday in April only). Said sum to be used for meeting the obligations incurred for maintenance and operation purposes only. Said sum does not exceed eighty-five percent (85%) of the anticipated revenues accruing to the District and shall be replaced from revenues accruing to the District before any other obligations are met from said revenues.
