SUBJECT: Temporary assignment differential for the Deputy Auditor-Controller during the initial implementation of the Fiscal Management Consolidation Act (Measure B).

Dear Board Members:

RECOMMENDATION: It is recommended by the Director of Human Resources and the Assistant Auditor-Controller that your Board approve the following effective February 8, 2009:

1. Authorize a 15% temporary assignment differential to the Deputy Auditor-Controller to acknowledge the added duties performed while the Assistant Auditor-Controller discharges the duties of the Auditor Controller's Office during the creation of and recruitment for the new Director of Finance position.

SUMMARY: During the initial implementation of the Fiscal Management Consolidation Act (Measure B), the Assistant Auditor-Controller has been assigned to discharge the duties of the Auditor-Controller's Office until the new Director of Finance is appointed. While the Assistant Auditor-Controller is assuming these additional duties, the Deputy Auditor-Controller will also be performing additional duties and responsibilities as part of the department's executive management team to ensure continuity in operations of the Auditor-Controller's Office. Staff is recommending a temporary assignment differential of 15% to acknowledge these added duties.

FISCAL IMPACT: There is no fiscal impact associated with this recommendation. The costs associated with this action will be offset by salary savings in the department.
