REGULAR MEETING OF THE MARIN COUNTY BOARD OF SUPERVISORS HELD TUESDAY, JUNE 9, 2009, AT 9:05 A.M.

#### FARMERS MARKET PROGRAM ENHANCEMENTS WORKSHOP

Cultural and Visitor Services Director Jim Farley and Facilities Planning and Development Manager David Speer presented an update on the development of a permanent site for the Marin Farmer's Market. The report included an overview of the Request for Proposal ("RFP"), the Vision Plan submitted in response by the Marin Agricultural Institute ("MAI"), and the recommendations of staff and the BOS Adhoc Subcommittee to reduce the project scope and establish criteria for a business relationship with the MAI.

Representatives of the MAI, staff and Board members discussed several issues including eliminating the permanent structures in the proposed design plan, conducting traffic and parking impact studies, and anticipated County financial commitment. Marin Center Renaissance Partnership Committee Chairman Al Boro requested that the Board consider the impact of a permanent farmer's market. Two members of the public commented on fiscal responsibility for site improvements.

Board members approved continuance of the BOS Adhoc Subcommittee and directed staff to develop business criteria to use in considering a multiyear agreement with the MAI for a scaled down version of their Vision Plan.

The Board took a brief recess at 10:08 a.m. and reconvened at 10:15 a.m. in the Board of Supervisors' Chambers, Room 330. Supervisor McGlashan was absent.

#### 4. ADMINISTRATOR'S REPORT

# Agenda Modifications

County Administrator Matthew Hymel requested that Item CA-7, regarding a Memorandum of Agreement with Audubon California, be removed from the agenda.

Mr. Hymel advised that Public Works has requested that Item CA-8b, regarding approval of plans and specifications for the American Recovery and Reinvestment Act ("ARRA") Pavement Resurfacing Project, Phase A, be removed from the agenda to be rescheduled for June 16, 2009.

Mr. Hymel requested that Item 14, regarding a first reading for an ordinance pertaining to the Marin County Integrated Pest Management ("IPM") Program, be removed from the agenda.

#### County Use of Pesticides

Mr. Hymel commented briefly regarding the County's use of pesticides and noted that staff is taking immediate action to review the information submitted by the public, to address and correct known issues, and to update program practices and policies to insure compliance with the County's current Integrated Pest Management ("IPM") Ordinance. Mr. Hymel advised that staff will continue to investigate this matter and will return to the Board with an update when all the facts are known.

#### County Use of Pesticides

Several members of the public, a representative of Mothers Advocating for Childrens' Health in Sonoma ("MACH Sonoma"), a representative of the Environmental Health Network and Ecology House, and representatives of Mothers of Marin Against the Spray ("MOMAS") expressed concern regarding the County's use of certain pesticides in public areas, requested an investigation into violations of the IPM Ordinance, and called for a public hearing on the matter.

Board members thanked the speakers for their input on the County's use of pesticides, advised that there will be an investigation to gather all the facts with the assistance of staff and the Integrated Pest Management ("IPM") Commission, briefly commented on the appropriate County response to community concerns, and advised that the IPM Ordinance is in the process of being reviewed and strengthened. Board members also emphasized the importance of community involvement and education regarding pesticide use in their neighborhoods and cities.

## State Budget Cuts

A representative of the Marin Center for Independent Living expressed concern regarding Governor Schwarzenegger's proposed budget cuts to adult day care, to services for traumatic brain injury and alzheimer's patients, to Medi-Cal provider rates, to In-Home Supportive Services ("IHSS") provider wages, and to services for certain IHSS clients.

# 12. HEARING: COUNTY-INITIATED NON-RENEWAL OF SELECTED LAND CONSERVATION CONTRACTS (WILLIAMSON ACT CONTRACTS)

By letter dated June 9, 2009, Community Development Agency Director Brian Crawford and Consulting Senior Planner Johanna Patri submitted their report and recommendations regarding the above-captioned matter. Mr. Crawford gave a brief background of the Williamson Act and introduced Ms. Patri.

Ms. Patri advised that the Community Development Agency ("CDA") conducted a review of all properties under 40 acres in size that are currently governed by a Land Conservation Contract and determined that 13 parcels were appropriate for non-renewal in accordance with State law. Ms. Patri advised that staff is recommending that the Board approve the proposed County-initiated non-renewal of selected Land Conservation Contracts for the 13 parcels within the unincorporated areas of Marin County identified in the proposed resolution and direct staff to issue Notice of Non-renewal to the affected property owners. Ms. Patri noted that none of the affected parcels were adjacent to larger parcels under the same contract.

Ms. Patri responded to questions from Supervisor Adams regarding building limitations on parcels after non-renewal of contracts and review of the proposal by the Marin agricultural community.
