**SUBJECT:** Amendment to 3-Year Master Fee for Service Contract For Marin Mental

Health Plan, Provider Contracts Under \$25,000 Each - FY 2006-2007 Through FY 2008-2009 (Decrease by \$26,000 – from \$900,000 to \$874,000)

### **RECOMMENDATION:**

- 1. Approve amendment to master contract for \$874,000 for 3 years (\$300,000 for each of the first two years, \$274,000 for the last year) to apply to fee for service contracts less than \$25,000 each, with Marin Mental Health Plan providers who provide services to Medi-Cal clients.
- 2. Authorize the Director of the Department of Health and Human Services to approve contracts pursuant to this master agreement.

#### SUMMARY:

The implementation of the SAP system has required a variety of changes in the County's contract accountings procedures. Staff from HHS, the CAO's office and from the Auditor's Office have developed the proposed "master contract" process in order to ensure the continued effective and timely delivery of services in areas where client needs vary over the course of a fiscal year. The proposed master contract process is consistent with the practices in other counties, including Alameda, Sonoma and San Luis Obispo.

Under the proposed arrangement, the Board approves the attached Master Contract and authorizes the Director of Health and Human Services to sign identical contracts with providers on the attached list, and additional providers whose services might become necessary in the future. The Director will advise the CAO's office quarterly of any additions or deletions of contractors under the Master Contract.

The total amount of the proposed 3-year master contract is \$874,000 or \$300,000 for each of the first two years and \$274,000 for the last year; the sum of the individual contracts will at no time be greater than this amount. Also note that the proposed master contract does not allow for a waiver of the County's insurance requirements; if a contractor seeks such a waiver, the Department will need to get the specific approval of the Risk Manager and the signature of the CAO (for contracts under \$25,000 each) or of the Board (for contracts greater than \$25,000).

#### **COMMUNITY IMPACT:**

Approval of the proposed master contract arrangement will allow the Marin Mental Health Plan to continue to provide mental health services in a manner that can best be adapted to changing patient needs.

## FISCAL IMPACT:

Funds for this request are budgeted in Fund Center 1000044000. A purchase requisition for each contract provider on the attached list has been entered in SAP. The amount of each requisition will be adjusted as needed throughout the fiscal year based on actual utilization of services not to exceed the annual maximum amount. This agreement is decreased in FY 08/09 by \$26,000 from \$300,000 to \$274,000. The \$26,000 will be moved into the budget for the Over \$25,000 Master Fee for Service Marin Mental Health Medi-Cal Managed Care Contract, which is budgeted in the same fund center and commitment item. There is no increase in net county cost.
