

WHEREAS, Peter N. Bretan, Jr., M.D. is a leader in disaster preparedness and response among the physician community in Marin; and



WHEREAS, in honoring April as "Earthquake Preparedness Month"; it brings to mind the people in the community who make an extraordinary effort in preparing their surroundings and their neighbors to respond to a disaster; and

WHEREAS, Flo deLosada started volunteering with the CERT program in 1998 and the Get Ready Committee for the City of San Rafael, and is currently the Director of the Central Marin Branch of the Marin Medical Reserve Corps (MMRC) as well as the MMRC Liaison Officer to Marin General Hospital and Dominican University. As Liaison Officer Flo represents the MMRC on matters relating to disaster preparedness and the MMRC. As Branch Director Flo coordinates the activities of over 100 MMRC volunteers who live in San Rafael, San Anselmo, Fairfax and Greenbrae. Flo was a volunteer for many years as a rescue swimmer on the San Rafael Police Boat and retired from the Police Department in 2002. She volunteers on the Forensic Multi-Disciplinary Team which partners with many community service providers who work with the mentally ill and law enforcement. Flo was first recognized by the Board of Supervisors in 1980 with a resolution signed by Barbara Boxer, for her work in Probate, and more recently recognized by Civic Center Volunteers and the Board of Supervisors for her participation in the MMRC. Besides her activities in the MMRC, Flo volunteers her time in other worthy community projects, including serving on the Board of Directors of the Parnow Friendship House, a member of National Alliance of Mental Illness, and helping to develop a Critical Incident Stress Program for Public Safety Officers;

WHEREAS, Christine Erlach is a volunteer with the Marin Medical Reserve Corps and was just recognized by the Surgeon General's Office as the "Outstanding MRC Public Health Volunteer". Christine will be honored by the Surgeon General's Office of the Civilian Volunteer Medical Reserve Corps (OCVMRC) at the 2010 Integrated Medical, Public Health, Preparedness, and Training Summit in Nashville, TN on May 12. Recipients of this award represent the best of the best in the MRC, carrying out successful public health activities on behalf of their MRC unit. Christine is being honored for her outstanding work in public health by leading a blood pressure screening program, serving as Nursing Group Supervisor for all 4 Points of Dispensing (POD) (which is set up to distribute large amounts of medicines to large numbers of people in a short period of time), and supporting the operations of a Field Treatment Site during a recent Marin MRC Hospital exercise; and

WHEREAS, Flo deLosada and Christine Erlach are examples of the true strength and importance of the MMRC -- volunteers who help make communities healthier, better prepared and more resilient.
