SUBJECT: Authorize the President of the Marin County Board of Supervisors to approve an amended Agreement for Professional Services between the Marin County Sheriff's Office and Open Space District. This agreement revises the number of deputies previously provided to the District from two deputies to one.

Dear Supervisors:

RECOMMENDATION:

1. Accept amended agreement between Open Space District and the Marin County Sheriff's Office for the performance of normal and customary law enforcement patrol services provided by one (1) full-time Deputy Sheriff.
2. Approve associated personnel costs assigned to Open Space District as outlined in Appendix A:

Annual DISTRICT Personnel Cost	Amount
Deputy Sheriff FTE; (full salary / benefits as of January 1 st 2010)	\$126,921
Deputy Sheriff Overtime Pay (cost per hour)	\$68.46
Uniform Allowance; (Paid to all Deputy Sheriff FTE)	\$920
P.O.S.T. Incentive Pay; (Paid to eligible Deputy Sheriff FTE)	\$4,500
Bilingual Pay; (Paid to eligible Deputy Sheriff FTE)	\$2,159

SUMMARY: The Marin County Sheriff's Office has provided the services of a Deputy Sheriff to the Marin County Open Space District for the last eighteen years. The agreement before the Board is a continuation of this service from the end date of the prior contract until either party notifies the other 30 days in advance if they wish to terminate the contract. We currently have two deputies assigned to patrol the OSD lands. In July, that number will drop to one.
