ORDINANCE OF THE MARIN COUNTY BOARD OF SUPERVISORS AMENDING SECTIONS 15.33.030, 15.33.031, AND 15.33.032 OF THE MARIN COUNTY CODE RELATING TO PARKING FINES IN STINSON BEACH, MUIR BEACH AND BOLINAS

THE BOARD OF SUPERVISORS OF THE COUNTY OF MARIN ORDAINS AS FOLLOWS:

SECTION 1. 15.33.030 of the Marin County Code is hereby amended to read as follows:

15.33.030 Stinson Beach parking fine zone.

The parking of vehicles on the following roads, or portions thereof is prohibited at all times:

- (a) Calle del Arroyo along the southerly side, beginning at its intersection with State Route 1 (Shoreline Highway) and extending northerly to its terminus at Seadrift Road; along the northerly side, beginning at its intersection with State Route 1 (Shoreline Highway) and extending northerly for a distance of three hundred feet; and along the northerly side, beginning at its terminus at Seadrift Road and extending southerly for a distance of one hundred twenty feet.
- (b) State Route 1 (Shoreline Highway) along the southerly side, beginning at its intersection with Calle del Pinos and extending southerly to its intersection with Calle del Mar. Every person violating this traffic order adopted under this section shall be guilty of an infraction and shall be punished upon a conviction by a fine established by resolution of the Board of Supervisors. Pursuant to Section 22650 et seq. of the California Vehicle Code, the county sheriff and California Highway Patrol are hereby authorized to tow away vehicles parked in violation of this section.

SECTION 2. 15.33.031 of the Marin County Code is hereby amended to read as follows:

15.33.031 Muir Beach parking fine zone.

The parking of vehicles on the following roads, or portions thereof is prohibited at all times:

- (a) Pacific Way along the northerly side from State Route 1 (Shoreline Highway) to its terminus; along the southerly side from its intersection with State Route 1 (Shoreline Highway) and continuing west for a distance of eight hundred fifty-eight feet; and along the southerly side beginning at its terminus and continuing east for a distance of seventy feet.
- (b) Pacific Way on Saturdays, Sundays and Holidays only between the hours of eleven a.m. and six p.m. along the southerly side beginning at a point eight hundred fifty-eight feet west of its intersection with State Route 1 (Shoreline Highway) and continuing westerly for a distance of three hundred thirty feet.
- (c) State Route 1 (Shoreline Highway) along the easterly side for a distance of eighty feet south and seven hundred twenty feet north from the centerline of Pacific Way and along the westerly side for a distance of one thousand four hundred sixty feet south and four hundred fifteen feet north from the centerline of Pacific Way.

Every person violating this traffic order adopted under this section shall be guilty of an infraction and shall be punished upon a conviction by a fine established by resolution of the Board of Supervisors.

Pursuant to Section 22650 et seq. of the California Vehicle Code, the county sheriff and California Highway Patrol are hereby authorized to tow away vehicles parked in violation of this section.

SECTION 3. 15.33.032 of the Marin County Code is hereby amended to read as follows:

15.33.032 Bolinas parking fine zone.

The parking of vehicles on the following roads, or portions thereof is prohibited at all times:

- (a) Wharf Road along the westerly side from its terminus one hundred feet north; along the easterly side from its terminus north for five hundred feet; along the easterly side beginning at a point five hundred fifty-three feet from its terminus and continuing north for a distance of four hundred forty-seven feet.
- (b) Brighton Avenue on both sides beginning at the western intersection with Park Avenue and continuing to its terminus.

Every person violating this traffic order adopted under this section shall be guilty of an infraction and shall be punished upon a conviction by a fine established by resolution of the Board of Supervisors.

Pursuant to Section 22650 et seq. of the California Vehicle Code, the county sheriff and California Highway Patrol are hereby authorized to tow away vehicles parked in violation of this section.

SECTION 4. This ordinance shall be liberally construed to achieve its purposes and preserve its validity. If any §, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and every section subsection, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional or invalid.

SECTION 5. Effective Date. This ordinance shall be and is hereby declared to be in full force and effect as of thirty (30) days from and after the date of its passage and shall be published once before the expiration of fifteen (15) days after its passage, with the names of the supervisors voting for and against the same in the INDEPENDENT JOURNAL, a newspaper of general circulation published in the County of Marin.
