Public Works Update

Public Works Director Farhad Mansourian reported on the award of \$1.3 million from the Metropolitan Transportation Commission ("MTC") to fund the repair of Atherton Avenue from Highway 37 to Olive Avenue, in Novato and the repair of Paradise Drive from Ranch Road to Trestle Glen Boulevard, in Tiburon.

Mr. Mansourian also reported that Senator Feinstein has included a federal funding allocation request for projects related to Corte Madera Creek, the Las Gallinas and Santa Venetia Levees and the Hamilton Wetlands.

California State Association of Counties ("CSAC") Legislative Analyst Faith Conley provided a brief update on several issues of interest to member counties including State budget reform, legislation currently under review, and CSAC resources available to members. Ms. Conley acknowledged Supervisor Adams for her leadership.

10. PRESENTATION FROM THE DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION OF AGING AND ADULT SERVICES, ON THE AREA PLAN FOR AGING FY 2010-2011 UPDATE

By letter dated April 20, 2010, Health and Human Services Director Dr. Larry Meredith submitted his report and recommendations regarding the above-captioned matter.

Deputy Director of Aging and Adult Services Nick Trunzo presented the Area Plan for Aging FY 2010-2011 Update and acknowledged the efforts of Dr. Marjorie Belknap and the Commission on Aging. Mr. Trunzo commented on the increases in Marin's senior population at the same time that funding for senior programs is decreasing. Mr. Trunzo also acknowledged the expanding role of volunteers to offset funding losses to senior programs.

Supervisor Kinsey encouraged Division of Aging staff and Commission on Aging members to advocate on behalf of the Senior Mobility Program, as well as for new funding streams for senior programs.

11. HEARING: CONSIDERATION OF MARIN SANITARY SERVICE'S REQUESTED 19.61% RATE INCREASE, EFFECTIVE MAY 1, 2010, FOR REFUSE AND RECYCLING SERVICES IN ROSS VALLEY NORTH FRANCHISE AREA

By letter dated April 20, 2010, Public Works Deputy Director Michael Frost submitted his report and recommendations regarding the above-captioned matter.

Mr. Frost presented a brief summary of the new services and rates contained in the proposed agreement.

Mr. Frost and Marin Sanitary Service Chairman Joe Garbarino responded to questions from Board members regarding comparisons to other service areas, public outreach efforts, vehicle impact fees, separation of recyclables, food waste to energy programs, tailoring agreements to franchise areas, and efforts to make refuse and recycling programs self-sustaining so the County no longer has to subsidize them.

The hearing was declared open to receive public testimony.

The Co-Director of the Green Coalition for Responsible Waste and Resource Management and the Energy Climate Chair of the State Sierra Club stated their objections to the proposed agreement, asked why competitive bids were not sought, and expressed concern regarding the distance to the composting facility.

A representative of the Marin Conservation League expressed support for zero waste programs, while recognizing that the proposed agreement is only a starting point.

Mr. Frost and Mr. Garbarino responded to speakers' comments regarding the viability of a local composting facility.

Seeing no one else present to speak, the hearing was closed.

M/s Supervisor Brown - Supervisor Kinsey to authorize President to execute amendment to the agreement with Marin Sanitary Service reflecting approved rate for refuse and recycling services in Ross Valley North Franchise Area, effective May 1, 2010.
