**RESOLUTION 12/10**

**RESOLUTION OF THE ROSS VALLEY PARAMEDIC AUTHORITY  
FOR AN ELECTION TO BE HELD ON NOVEMBER 2, 2010 TO  
CONTINUE A TAX FOR PARAMEDIC SERVICES**

RESOLVED, BY THE BOARD OF DIRECTORS OF THE ROSS VALLEY PARAMEDIC AUTHORITY FOLLOWS:

WHEREAS, on March 1, 1991, the electors of the Ross Valley Paramedic Authority approved a special tax for the funding of paramedic services through the Ross Valley Paramedic Authority; and

WHEREAS, the maximum allowable tax was established at \$30.00 per residential unit and \$30 per 1500 square feet of commercial; and

WHEREAS, the Ross Valley Paramedic Tax has been annually levied and each four years the tax rate reset and approved by election; and

WHEREAS, this special tax shall duly expire effective June 30, 2011;

NOW, THEREFORE BE IT RESOLVED;


The Board of Directors of the Ross Valley Paramedic Authority does hereby call for an election on November 2, 2010, for the purpose of increasing the special tax for paramedic services for an additional four years beginning at \$42 in the first year to a maximum amount of \$51 (plus an additional .50 cents County administrative fee) per residential unit in the fourth year, and \$51 (plus an additional .50 cents County administrative fee) per 1500 square feet of structure developed parcel in non-residential use in the fourth year.


