Amendment to Community Development Block Grant Agreement

Rehabilitation Loan Program

(Housing Authority of the County of Marin)

RECOMMENDATION: Authorize the President to sign Amendment 16 to Appendix C (Budget) of Agreement with the Housing Authority of the County of Marin for the Rehabilitation Loan Program.

SUMMARY: On October 18, 1994, the Board of Supervisors approved a Community Development Block Grant (CDBG) Agreement with the Housing Authority of the County of Marin for the Rehabilitation Loan Program.

On May 4, 2010, the Board of Supervisors allocated \$173,713 in additional CDBG funding for this program. The Housing Authority will supplement its CDBG allocation with program income from repayments of prior years' loans. All program income (principal and interest payments on program loans) is retained in the revolving loan fund to make additional rehabilitation loans. All of the new CDBG funds are allocated for staff expenses and program administration by Housing Authority staff.

In addition to its traditional role serving single-family owner-occupied houses (including mobile homes and houseboats), the program will also assist nonprofit-operated group homes serving special populations. The following group home has been designated for inclusion in the Rehabilitation Loan Program for the 2010-11 program year:

After Waldo Point Harbor receives County permits, the Rehabilitation Loan Program will make a major shift in its activities to help Gates Cooperative members upgrade their boats to meet code standards so that they can qualify for berths in the new Waldo Point Harbor.

The attached amendment to the contract supplements Appendix C with a new budget for \$173,713 in new CDBG funds allocated for this project. The attached Budget Amendment 16 includes only funds that have not been included in any previous contract or contract amendment for the Rehabilitation Loan Program. Budget Amendment 16 increases the contract amount for the Rehabilitation Loan Program by \$173,713, resulting in an increase in the total contract amount from \$2,739,728.91 to \$2,913,441.91.

FISCAL IMPACT: Because the County's contribution to this project is in the form of federal CDBG funds, there is no financial impact on County general funds.
