SUBJECT: Temporary closure of Fairfax-Bolinas Road for the annual Mount Tamalpais Hill Climb bicycle ride on Saturday, September 18, 2010

Dear Board Members:

RECOMMENDATION: Approve temporary closure.

SUMMARY: The California Road Club has requested temporary closure of one lane of Fairfax-Bolinas Road for the annual Mount Tamalpais Hill Climb bicycle ride. Fairfax-Bolinas Road will have temporary traffic control measures in place on Saturday, September 18, 2010, from 9:00 am to 12:00 pm.

FISCAL IMPACT: None.

DISCUSSION: An encroachment permit will be issued including the following constraints:

- 1. Traffic control shall be provided by the applicant at their expense and approved prior to the event by the California Highway Patrol and Sheriff.
- 2. Access shall be maintained at all times for emergency vehicles and residents.
- 3. Signs and barricades shall be placed to denote road closure and redirect traffic.
- 4. All litter and debris shall be removed immediately upon conclusion of the event.
- 5. Applicant shall post the proposed street closure date and time along the route within County jurisdiction and in the vicinity of the Meadow Club, no later than 5:00 pm on Friday, September 10th to provide advance notice to travelers.
- 6. On the day of the event, applicant shall post notification signs and detour signs for the road closure. Notification signs shall be placed at each end of the road closure. Detour signs shall be placed 100' ahead of the road closure.
- 7. Participants shall obey all traffic laws and remain in their traffic lane.
