**SUMMARY:** Under the Agreement approved by your Board on October 28, 2008, funds have been allocated to the County of Marin in order to improve the capabilities of the Marin County Operational Area to respond to a terrorist attack or natural disaster.

This MOU 1) increases the allocated funds to \$158,637 to provide for one Sheriff's Sergeant to work and participate in the Northern California Regional Intelligence Center for the balance of FY 2009-10, and 2) modifies the Article of Insurance to require compliance by subcontractors. The full-year fiscal impact of the position is an estimated \$158,637 (offset by additional revenue) in the same amount.


