**SUBJECT:** Request from the Marin County Triathlon Inc. for temporary road closure and traffic control on North San Pedro Road from County limits at the southern end of China Camp State Park west to just beyond the Back Ranch Meadows campground entrance on Sunday, October 31, 2010 from 7:30 a.m. to 12:30 p.m. for the bike and run portion of the Marin County Triathlon, based at McNear's Beach Park, San Rafael – District 1

Dear Board Members:

**RECOMMENDATION:** Approve the temporary road closure for the time and date specified below.

**SUMMARY:** The Department of Public Works has received a request from the Marin County Triathlon, Inc. to temporarily close North San Pedro Road, with traffic control, for the bike and run portion of the Marin County Triathlon, on Sunday, October 31, 2010 from 7:30 a.m. until 12:30 p.m. Course closure will affect North San Pedro Road from County limits at the southern end of China Camp State Park west to just beyond the Back Ranch Meadows campground entrance, monitors will be placed at other intersections and CHP will be patrolling the entire race course, and providing traffic control at other major cross streets.

**FISCAL IMPACT:** None.

**DISCUSSION:** An encroachment permit will be issued including the following conditions:

1. Traffic control shall be provided by the applicant at their expense and approved prior to the event by the California Highway Patrol and Sheriff.
2. Access shall be maintained at all times for emergency vehicles and residents.
3. Signs and barricades shall be placed to denote road closure and redirect traffic.
4. All litter and debris shall be removed immediately upon conclusion of the event.
5. A message board shall be provided by the applicant at least 10 days in advance of the event in the Santa Venetia neighborhood notifying the public of the road closure.
