

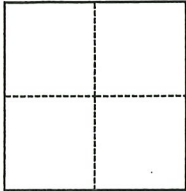

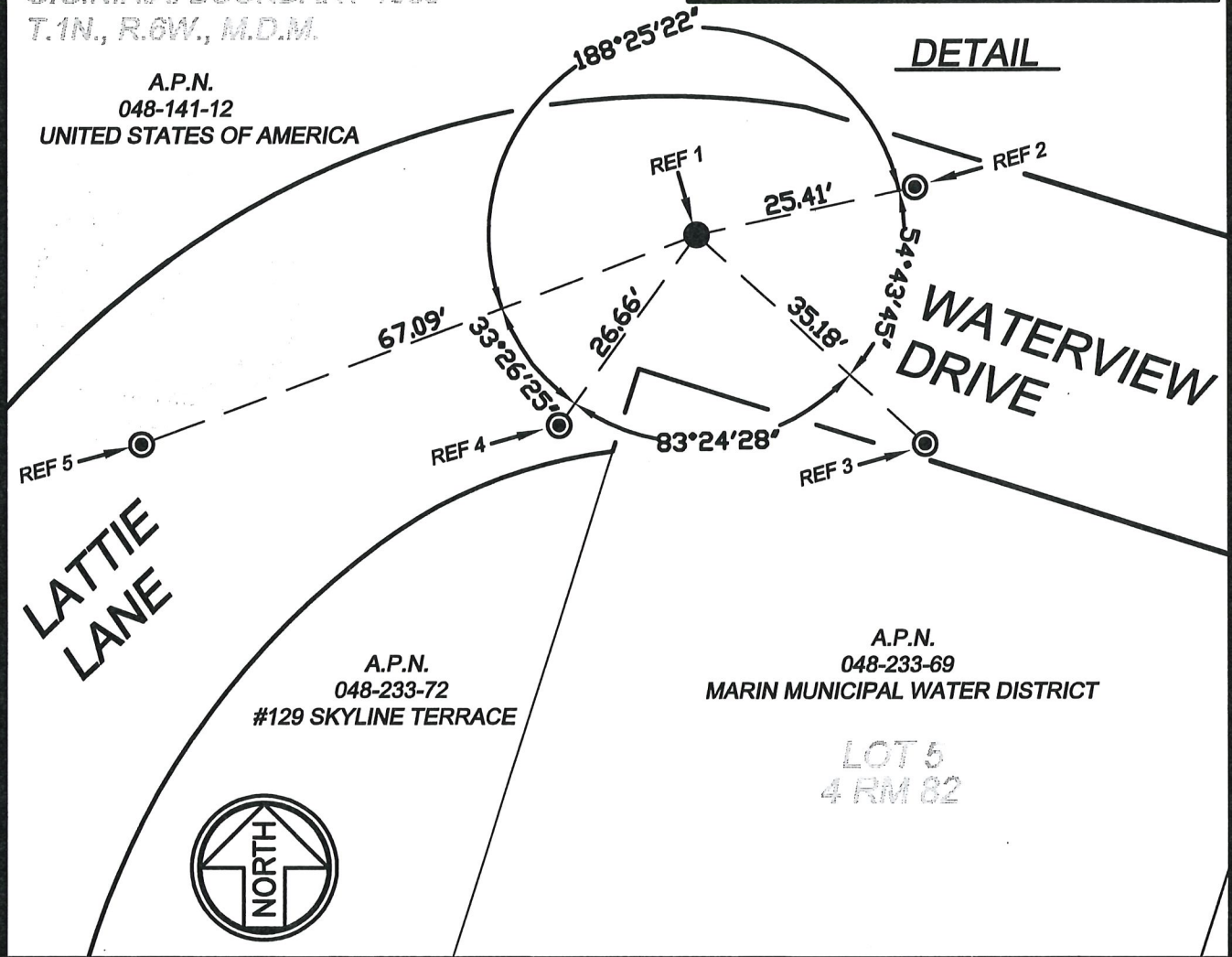

- REF 3: SET MAG NAIL AND WASHER STAMPED "MARIN COUNTY SURVEYOR " ON ASPHALT BERM.
