Identification and type of corner found: Evidence used to identify or procedure used to establish or reestablish the corner:

The City Street Monument in Catalina Blvd., 93 feet Southwest of the intersection of Catalina Blvd. & Spinnaker Point (formerly Canal St.) was located to perpetuate its position prior to sewer line construction and to re-establish its position. No attempt was made to determine the validity of the monument or its proper location in relation to legal boundary lines in the area.

A description and the physical condition of the monument as found and as set or reset:

The existing brass disk in a Standard City Street Monument well in the above described location was found in good condition prior to construction. After construction it was re-established and rebuilt with a 3" Aluminum Disk punched & Stamped "PLS 8118" "Replaced by Corner Record"

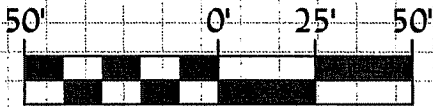
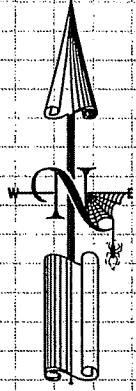
